What is a Family Council

1. **Family councils** help families give each other the **support** and **encouragement** they need.
2. **Family councils** are a forum for **education** and **information** about residents' rights, health care, and nursing home operations.
3. **Family councils** let families organize their **collective concerns** without overwhelming facility staff.
4. **Family councils** build trust between families and staff, developing the **communication** necessary to improve life for all residents.
5. **Family councils** increase resident involvement with their **community**, through sponsored activities.

Family Councils Have Improved Residents' Lives

- Advocated for new doors in the Alzheimer unit to ensure residents' safety.
- Invited the Director of Nurses to teach families how to prevent bedsores.
- Cleaned out storage closets after noticing that many of the residents' clothes were missing. As a result, many misplaced garments were found.
- Sponsored staff appreciation and educational programs.
- Worked out billing and delivery issues with the facility's drug distributor.
- Urged the home to assign the same nursing assistants to the same residents, improving resident care and staff job satisfaction.

The Right to Have a Family Council

Federal law says the family and friends of nursing home residents have the right to hold regular private meetings of an organized group called a "**family council.**" Just as schools have a parents' association, a nursing home **can** and **should** have a family council. Nursing homes in the Medicare and Medicaid programs must:

- provide a meeting space
- cooperate with the council's activities
- respond to the group's concerns.
